## FOSTER CARE AGREEMENT AND RELEASE OF LIABILITY

This document provides for the release of liability of the Central California Labrador Retriever Rescue, Inc. (CCLRR) organization and its members and representatives due to the actions of any Labrador Retriever or Labrador Retriever Mix (dog) which has been released into the ownership of CCLRR and placed into a foster home with:

I, the Foster Care provider named above, understand that although CCLRR, its members, and representatives, have made every effort to evaluate the temperament of dogs placed in foster care, it is impossible to predict the behavior of every dog in every situation. Therefore I must take necessary precautions to prevent accidents and guard against un-predicted actions by any dog I foster.

Further, I agree to take adequate care of the dogs I foster while they are in my possession, providing food, water, and shelter as needed. I also promise to notify CCLRR if any fostered dog is in need of veterinary care. All foster dogs will be taken to a vet for an examination, Spay/Neuter, Fecal Test, DHLPP, Rabies and Heart Worm test by CCLRR or me. Any treatment prescribed by the veterinarian will be administered by me as required. All Foster dogs will be given a collar and a CCLRR ID tag and the tag number Registered with the CCLRR Coordinator. This collar and ID Tag stays on the dog at all times and goes with the dog at adoption.

At no time will I allow this dog to be a nuisance to people or other animals. To that end I will keep it safely confined in a fenced yard or kennel run, or inside a house or garage when it is not with me or a member of my family. At no time will the dog be placed outside on a tie-out unless under the direct supervision of a responsible adult. When off my property, the dog will be kept on a leash unless it is in a fenced area approved for free running dogs.

I understand that I may donate any expense incurred by my foster dog, however, CCLRR agrees to pay for or reimburse me for:

1. Food, including any special food required by a sick dog.
2. All veterinary expenses including spay/neuter. HOWEVER, all non-emergency veterinary treatment must be pre-authorized by a CCLRR Board member.

I agree to show my foster dog to prospective adopters by appointment. Since I will know my foster dog better than anyone else, should I feel a prospective adopter is not the right person for my foster, I have the right to refuse to allow the dog to be adopted by that person. In such a case I will immediately contact a Board member and state my reasons for such a refusal and refer the prospective adopter to that Board member.

I understand that fostering a dog for CCLRR is not the same as adopting a dog from them, and if I wish to adopt a dog which I foster, then I must fill out an adoption application.

I agree to return my foster dog to CCLRR immediately upon request.
